2 P R O C E E D I N G S

3 COUNCILMAN DICICCO: Good afternoon,
4 everyone. The hearing on the Committee on Streets
5 and Service is now in session.

6 My name is Councilman DiCicco. With me
7 today, to my far left, is Councilwoman Clark.
8 Councilmember Nutter, Councilmember Rizzo. And to
9 my right is Councilman Mariano. We have a quorum.

10 The clerk will please read the title of
11 the first bill.

12 THE CLERK: Bill No. 980457, an
13 ordinance authorizing the striking from City Plan
14 No. 244 and abandoning a certain right-of-way for
15 drainage purposes from Haines Street to Eastburn
16 Avenue, under certain terms and conditions.

17 COUNCILMAN DICICCO: Please state your
18 name for the record.

19 MR. LONIE: Good morning, Mr. Chairman
20 and members of the committee. My name is Paul
21 Lonie, and I'm representing the Department of
22 Streets. I'm here to offer the following
23 testimony on Bill No. 980457.

24 This is not an administrative
25 ordinance. Robert Lane, Esquire, of Morgan, Lewis

2 & Bockius, has requested the City to strike and
3 abandon a non-needed drainage right-of-way and
4 allow for the expansion of Amoco Oil Company and a
5 McDonald's facility and several other contiguous
6 parcels. This ordinance is supported by the
7 Department of Streets and is recommended to the
8 committee for favorable action.

9 COUNCILMAN DICICCO: Are there any
10 questions for this witness from the committee?

11 (No questions.)

12 COUNCILMAN DICICCO: Is there anyone
13 else here who wishes to testify for or against the
14 bill?

15 (No response.)

16 COUNCILMAN DICICCO: For the record, I
17 would also like to also acknowledge the presence
18 of Councilwoman Tasco and Councilman Cohen. We
19 have enough of a quorum for tomorrow, actually.
