11 No. 060500.

12 This is a Councilmanic
13 ordinance requested by Councilman Michael
14 Nutter.

15 The purpose of this ordinance
16 is to extend the time to authorize the
17 Board of Surveyors to legally close a
18 portion of this street.

19 This ordinance is supported by
20 the Department of Streets and is
21 recommended to your Committee for
22 favorable action.
