3 starting shortly at 4 o'clock.

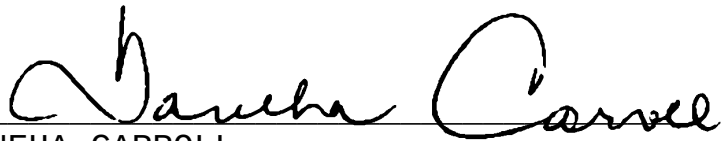
