COUNCIL PRESIDENT CLARKE:

quorum of Committee members.

The Clerk will please read the
title of the bill before us today.

THE CLERK: Bill No. 170206, an
ordinance authorizing and approving the
execution and delivery of a Service
Agreement between the City of
Philadelphia and the Philadelphia
Authority for Industrial Development
relating to the financing of the City of
Philadelphia's Rebuild program, approving
the issuance by the Philadelphia
Authority for Industrial Development of
bonds, notes or other evidences of
indebtedness in one or more series to
finance or refinance such program and
authorizing and approving the obligation
of the City of Philadelphia to pay in
full when due the Service Fee and other
amounts payable under the Service

2 Agreement; authorizing certain City
3 officers to take certain actions required
4 to issue such bonds, notes or other
5 evidences of indebtedness; covenanting
6 that the City of Philadelphia will make
7 necessary appropriations in each of the
8 City's fiscal years to provide for, and
9 will make timely payment of, the Service
10 Fee and other amounts due under the
11 Service Agreement; and authorizing City
12 officials to take necessary or
13 appropriate actions, all under certain
14 terms and conditions.

15 COUNCIL PRESIDENT CLARKE:

16 Thank you, Mr. Christmas.

17 This is a brief bit of clarity
18 on the process. Bill No. 170206 had a
19 public hearing on June 7th, and extensive
20 testimony was taken at that hearing.
21 After hearing all the testimony on the
22 bill, the public hearing was concluded
23 and the bill was amended at a public
24 meeting. The public meeting was then
25 recessed until today so that the
