12 Law," by providing a limited period of time during
13 which certain Drinking Establishments may apply
14 for and obtain a waiver of the provisions of the
15 Section prohibiting smoking in certain places,
16 under certain terms and conditions.

17 COUNCILMAN GREENLEE: Thank you. Is there

19 testify on this Bill?
