1 6/7/10 LABOR AND CIVIL SERVICE - BILL 100286

2 COUNCILMAN GREEN: I'm going to
3 call to order the Committee on Labor and
4 Civil Service.

5 I note that a quorum is
6 present, and Councilman Curtis Jones,
7 Councilman Maria Quiñones-Sanchez, and
8 Councilman Bill Greenlee are present.

9 I will just read the bill
10 myself. This hearing is continued from a
11 hearing last Wednesday relating to Bill
12 No. 100286. And title of the bill has
13 already been read into the record.

14 For the record, I'd like to say
15 that several of us on the committee have
16 had the opportunity to meet with Rob
17 Dubow, Shannon Farmer, and someone from
18 the Labor Office and Joe Tolen about this
19 matter. And we've had the opportunity to
20 sit down with a number of the municipal
21 unions on this matter.

22 And I have before me, and
23 before the committee, amendments that
24 will, as required under State law,
25 authorize Plan 10 for the police union.

2 And we'll leave for another day, after we
3 have more information, including a
4 complete impact study on Plan 87 and
5 other matters, the extension of that plan
6 to any other City employee.

7 That being said, is there
8 anybody else here to testify on this
9 bill?

11 COUNCILMAN GREEN: Seeing none,
12 I'm going to recess the public hearing
13 and move into the public meeting.

14 The committee will stand in
15 recess for 30 seconds.

1 6/7/10 LABOR AND CIVIL SERVICE - BILL 100286

2 COUNCILMAN GREEN: We are now
3 in a public meeting on Bill No. 100286.

4 Prior to recognizing Councilman
5 Bill Greenlee, I want to state for the
6 record that there are several resolutions
7 currently before this committee
8 addressing pension issues on a holistic
9 and global basis. And this committee
10 intends to work over the summer with the
11 Administration and other stakeholders to
12 try to find other solutions, do a little
13 bit more research on potential solutions
14 to the overall pension problem affecting
15 all City employees, in the hopes that we
16 can recognize or identify other ways to
17 solve the problem once and for all,
18 rather than on a piecemeal basis.

19 With that, the Chair recognizes
20 Councilman Greenlee.

21 COUNCILMAN GREENLEE: Thank
22 you, Mr. Chair.

23 I move the adoption of the
24 amendments to Bill No. 100286 that you
25 discussed in the public hearing.

19 recommendation, and move further that the
20 rules of Council be suspended to allow
21 for first reading at our next session of
22 Council.

24 COUNCILMAN GREEN: It has been
25 moved and seconded that the bill be
